

# Queensland Community Racing Scheme (QCRS) Trainer Licence Application

#### **Instructions for Completing This Form**

You must obtain a QCRS Trainers Licence if you intend to train horses to race at a Queensland Community Racing Scheme meeting. All Trainers, stable hands, track work riders and interested people with the relevant skills may apply for a QCRS Trainer Licence.

You need to attach to this application form:

- 3 references from licensed trainers attesting to your competency, skills and suitability to hold a QCRS Trainer Licence;
- A National Police Certificate, which you may obtain from your local police station or accredited agency. Must have been issued within the previous 12 months.
- evidence of your identity (copy of driver's licence, passport); and
- a passport size photograph of yourself.

#### What happens after I lodge my application form?

When you have satisfactorily completed the written application form, The Queensland Racing Integrity Commission (QRIC) may want to assess your competency as a QCRS Trainer. If this occurs, an assessment may be undertaken in relation to your ability to train a thoroughbred racehorse as well as your general knowledge of the rules of racing. Should you successfully complete the competency test, the QRIC may issue you a QCRS Trainer Licence on conditions.

Submission of this application does not guarantee approval. Applications may be deferred for further investigation, interview or for any other reason at the Queensland Racing Integrity Commissions (QRIC's) discretion.

## **Criminal history**

As part of the consideration of your licence application, the QRIC requires every applicant to obtain a National Police Certificate from his or her local police station or online and attach the original certificate to this application. If you are not an Australian citizen, you may need to obtain a National Police Certificate from your country of origin and submit proof of working rights in Australia.

A prior criminal history does not prevent a person from obtaining a licence, but any prior convictions are taken into account when deciding whether an applicant is an appropriate person to be involved in thoroughbred racing in Queensland. The QRIC may disclose any relevant prior convictions to your proposed employer.
